MOVING IN OR MOVING OUT?

Moves must be scheduled 48 hours in advance. Moving dates are on a first come first served basis. Mondays – Saturdays only from 9:00 am – 6:00 pm. No moves on Sundays. Move in Fee is \$150.00. If not paid by resident will be charged to the owner's account. \$500 fine will be imposed if move in is not authorized.



Fire Extinguishers

Residents are not required to have a portable fire extinguisher in their unit. Fire extinguishers are available in the common hallway for use in case of an emergency. You may choose to



purchase a small kitchen extinguisher available at Home Depot or Ace Hardware. Just check the expiration date.

FIRE SAFETY EQUIPMENT FORM

Please be notified that during the month of March you will receive the City and County of Denver Residential Fire Safety Equipment Report for completion. Please take the time to check your unit's smoke detectors and carbon monoxide detectors, and replace the batteries. Complete the form and return it to the building's office at your earliest convenience. The building is inspected by the Fire Department yearly and in addition to reviewing the common area safety elements, there is a need to present an updated file with the Fire Department's Fire Safety Equipment reports.
