### AMENDED AND RESTATED TRAIL EASEMENT

THIS AMENDED AND RESTATED TRAIL EASEMENT ("Restated Easement Agreement") is made this 2 day of 2014 between the GEORGETOWN VILLAGE HOME OWNERS ASSOCIATION, a Colorado non-profit corporation (hereinafter referred to as "Grantor") and the SOUTH SUBURBAN PARK AND RECREATION DISTRICT, f/n/a South Suburban Metropolitan Recreation and Park District, a quasi-municipal corporation and political subdivision of the State of Colorado (hereinafter referred to as "District").

### WITNESSETH

WHEREAS, on May 14, 1986 Grantor conveyed to District that certain trail easement recorded in the Arapahoe County Clerk and Recorder's office on July 30, 1986 in Book 4832 at Page 524 (the "Original Easement"), that extended in, through, over, and across a ten foot wide tract of land that extends from South Fairfax Way on the west to South Forest Way on the east (the "Original Easement Area"); and

WHEREAS, the District desires to realign, in part, and enlarge, improve and extend the trail constructed within the Original Easement Area and, to do so, needs to acquire a new easement that is generally ten feet wider than the Original Easement Area, and includes additional area that is generally adjacent to South Forest Way as it extends east to South Holly Street; and

WHEREAS, the Grantor and District desire to enter into this Restated Easement Agreement so that from and after the date hereof, the area of Grantor's property that is subject to the new easement, which includes the Original Easement Area, shall be governed by the terms and provisions set forth in this Restated Easement Agreement.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) paid by the District, the receipt and sufficiency of which is hereby acknowledged by Grantor, and in consideration for the covenants and conditions hereinafter set forth, Grantor hereby grants, bargains, sells, and conveys to the District, its successors and assigns, a perpetual easement ("New Easement") to construct, operate, maintain, repair and replace, at no cost to Grantor, a trail in, through, over, and across that portion of Grantor's real property described and depicted on Exhibit A (consisting of five pages) and Exhibit A-1 (consisting of nine pages) as attached hereto and incorporated herein by this reference ("New Easement Area"); provided, however, that at such time as the New Easement Area is no longer used for such purposes, the New Easement including any and all rights obtained by District under the Original Easement shall, without legal process, forthwith revert to the Grantor.

**IT IS HEREBY** mutually covenanted and agreed by and between Grantor and District as follows:

1. No Termination or Release of Original Easement. This Restated Easement Agreement shall in no way release or terminate the grant of the Original Easement, which

shall remain in full force and effect, except that from and after the date of this Restated Easement Agreement the covenants and restrictions set forth in the Original Easement shall be superseded and replaced by the covenants and restrictions set forth in this Restated Easement Agreement.

- 2. <u>Use of Easements</u>. The New Easement Area may be used by the District, its successors and assigns for the purpose of constructing, operating, maintaining, repairing and replacing, at no cost to Grantor, a trail and related improvements. Subject to such rules and regulations as the District may from time to time adopt, the District may permit use of the New Easement Area by members of the general public for recreation purposes, including but not limited to, walking, running and bicycle riding. Notwithstanding any other provision contained herein to the contrary, however, no portion of the New Easement Area (including any part that was part of the Original Easement Area) shall be used by motor vehicles including, but not limited to, cars, trucks, go-carts, and motorcycles, except to the extent necessary to: (i) permit the District to construct, operate, maintain, repair and replace its trail and related improvements; (ii) for emergency and law enforcement vehicles and purposes; and (iii) to provide access to the trail to persons with disabilities as required by the Americans with Disabilities Act or other similar law.
- 3. <u>Trail and Related Improvements</u>. The trail and related improvements shall consist of such materials and shall be of such design as the District determines appropriate; provided, however, Grantor shall have the right to review and approve the plans and specifications for the trail and related improvements, which approval shall not be unreasonably withheld, conditioned, or delayed.
- 4. <u>Indemnification</u>. To the extent permitted by law and without waiving any of the immunities, protections, and defenses afforded District under the Colorado Governmental Immunity Act, Section 24-10-101, et. seq., C.R.S., District shall indemnify and hold harmless Grantor from and against any and all liability, damage, loss or expense sustained by Grantor and that arises from or is anyway related to the negligence of District in the construction, operating, maintenance, replacement and repair of the trail and related improvements.
- 5. <u>Insurance</u>. The District shall maintain and keep in full force and effect commercial general liability insurance in the amounts specified in the Colorado Governmental Immunity Act, as the same now exists or may hereafter be amended from time to time, currently \$350,000 per person, \$990,000 per occurrence for bodily injury and property damage, or in the alternative the District shall adequately self-insure for such risks.
- 6. **Maintenance**. The District shall maintain the trail constructed within the New Easement Area in accordance with its standard maintenance policies and specifications, which shall include periodic sweeping, snow plowing, and concrete repair.
