All those in the pool area should be considerate of other homeowners both in the pool area and those living in the surrounding homes, refrain from yelling, screaming and using profane or inappropriate language. INFORMATIONAL MEETING May 8, 2017 Hail & Wind Event and Claim to be held JULY 11, 2017 at 6:30 pm in the Quailridge Clubhouse. Refreshments will be served. Please ioin us for this important meeting.

A letter from ASR Companies, the contractor engaged to perform restoration work following the wind and hail event is enclosed. Please take a moment to review this important information.

Insurance Reminder,

As you are aware and per previous notifications, the Association recommends that Owners carry an HO6 Townhome/Condominium Insurance Policy. Please be advised that carrying this coverage is more important than ever.

Recent changes in the Colorado insurance environment make it necessary for our Association to make changes to our Master Insurance Policy through Travelers Insurance Company, in order to keep our premiums reasonable.

Following the May 8, 2017 Wind and Hail event damage, an assessment will be levied to each Homeowner for their Undivided Interest Share of the total deductible which equates to 2% of the total property value. This amount will be **approximately** \$4,245.00 per unit with attached garage and \$3,185.00 per unit for the remaining 90 units.

Homeowners who obtained a Loss Assessment Endorsement through their insurance carrier will have this added protection. The coverage is very affordable, in the range of \$5.00 to \$10.00 per year additional premium for \$1,000 to \$10,000 of coverage. This Endorsement offsets the exposure to the deductible. If you do not have the Endorsement on your HO6 policy, you will be responsible for paying the Assessment on your own. However, if you have the Endorsement you can turn in a claim to your HO6 carrier and recover the money minus your deductible enabling you to cover the cost.

The Association recommends that you contact your insurance agent to confirm that you have the Loss Assessment clause in your HO6 policy.

It is also important to contact your agent and advise that you will soon be receiving the Loss Assessment letter in reference to the Association's May 8, 2017 Wind and Hail event claim, stipulating the exact amount of the assessment.
