This office has received several complaints regarding the noxious odors from marijuana being used in units on both the first and second floors of the building. The complaints came from residents entering the front of the building who note a strong odor of marijuana in the lobby at different times of the day. Once again we ask that the necessary steps be taken to maintain these fumes/odors within the walls and windows of a unit. Please take the necessary steps to install additional weather stripping, and perhaps the placement of wet towels. Units identified will be issued fines.

Please note Section 25-14-203 of the Colorado Revised Statutes, seeks to "preserve and improve the health, comfort, and environment of the people of this state by limiting exposure to tobacco and marijuana smoke."
